Legislative and Case Law Update

Key bills affecting workers' compensation

SB 1122 – ensures that designated doctor and other similar exams that health care providers conduct in the workers' compensation system are not subject to a sales and use tax.

Key bills affecting workers' compensation

HB 2468 – makes changes to lifetime income benefits eligibility standards:

- traumatic brain injury;
- expands third degree burns; and
- changes for first responders LIBs relating to employment capabilities and expedited dispute resolution proceedings.

Update on Recent Workers' Compensation Case Law

Network requirements and emergency care case:

Texas Mutual Ins. Co. v. Hand & Wrist of Houston, PA. Cause No. D-1-GN-22-004975 Travis County District Court Issue:


When out-of-network health care provider's initial treatment is "emergency care," triggering a payment obligation under Texas Insurance Code § 1305.006(1), does follow-up or continuing care for the same underlying condition also constitute "emergency care" for purposes of the out-of-network payment exception?

Recent Rule Changes

Required Certification Testing

Designated doctors and other certifying doctors are only required to have passed the required certification test at least once since May 13, 2013.

 No longer required to take the certification test every two years, unless specifically asked by DWC.



Continued Certification Training

DDs and other certifying doctors must <u>still</u> take required certification training every two years.

- DDs must continue to reapply for certification using the DWC Form-067, Designated doctor certification application.
- Other certifying doctors must submit documentation that they have taken the training every two years.



Designated Doctor Certification Application

DDs must still apply for a renewal every two years. A DD must:

- have a completed DD certification application on file with the DWC 45 days prior to expiration.
- complete all DWC related trainings within 12 months of the date of the application;



Revised Qualification Standards for Designated Doctor Examinations

 Changes are found in 28 TAC Sec. 127.130,
 Qualification Standards for Designated Doctor Examinations.

 Qualification revisions apply to exams ordered on or after June 5, 2023.

Designated Doctor Exam Types Impacted

Exam Types

Traumatic brain injury (TBI)

Spinal cord injuries →

Multiple fractures

General Changes

- Added several physician board specialties for TBIs.
- Only physicians with certain board specialties for spinal cord injuries.
- Expanded qualifications for simple fractures.



Important Dates

On or after April 30, 2023, DDs and other certifying doctors that pass or have previously passed the certification test on or after May 13, 2013, are no longer required to retest every two years when they renew their certification.

On or after June 5, 2023, a DD will only provide multiple certifications of MMI and IRs when DWC directs.

On or after June 5, 2023, exam orders will use the new qualification standards for exams.

Important Dates

On or after June 5, 2023, requesters must use the new DWC Form-032 Request for DD examination, with a 30-day grace period.

On or after June 5, 2023, DDs must begin using the new DWC Forms 32 and 68.

Future Rule Revision Proposals

Designated Doctor and Other Certifying Doctor Fees Being Revised

- Rules found in Chapter 134 and 133 are being revised to simplify billing and adjust fees for maximum medical improvement, impairment rating exams and other similar services.
- Three informal drafts with billing examples have been published, beginning in August of 2022 through June of 2023.
- Formal proposal expected soon.

Designated Doctor and Other Certifying Doctor Fees Being Revised

- Adjusts the fees once by applying the Medicare Economic Index (MEI) percentage adjustment factor for the period 2009-2024.
- Adjusts the fees annually on January 1 (after that initial adjustment) by applying the MEI percentage adjustment factor in Section 134.203(c)(2).
- Rounds the fees to whole dollars.
- Creates a \$100 missed appointment fee.

Opportunities to Participate in Workers' Compensation System

Workers' Compensation Doctor Roles

Treating, referral or consulting doctor:

- Create a TXComp profile and disclose financial interests.
- Join workers' compensation certified health care networks, the standardized application form found on DWC website, as well as a list of networks and contact information.
- Reimbursement for non-network is 191% of Medicare rates for in office procedures and 240% for surgery in a facility (professional fees).

Workers' Compensation Doctor Roles

Designated Doctor or Certifying Doctors:

- May be a treating/referral/consultant doctor also.
- Must have passed the certifying doctor test at least once since May of 2013.
- Training every two years.
- Fees are being revised.

Workers' Compensation Doctor Roles

Medical Quality Review Panel expert:

- Serve as a medical expert for DWC's Office of Medical Advisor.
- MQRP needs more orthopedics doctors, especially ortho spine.
- MQRP members are used on an as needed basis and are paid for the time spent on reviews and reports.

Intake and Treating the Compensable Injury

Ask the patient if the treatment they are seeking due to a work-related injury.

 Ask <u>all patients</u> this question and get their response in writing.

 It may help to ask this question more than once and expressed differently.

ex: Where did this injury occur? Were you working at the time of the injury?

Ask the patient if they have any outstanding disputes on compensability, extent of injury or liability (CEL) issues (PLN01 or PLN11)?*

*Insurance carrier is required to send notice of any benefit disputes (PLN01 or PLN11) directly to the injured employee (claimant). Ask for a copy.

Ask the referring doctor if they are aware of any disputes on CEL? If yes, ask:

- What conditions have been disputed and ask for copy of the PLN01 or PLN11.
- Do they have medical bills denied for this reason? If yes, have they pursued dispute resolution and what was the outcome?
- If there is a dispute over CEL, will they help with causation information?

Ask the insurance adjuster if there are any outstanding CEL disputes on the claim? If yes:

- Ask for a copy of the outstanding PLN01 or PLN11 (to review the conditions/dx being disputed).
- Insurance carrier is not required to send the PLN01 or PLN11 to the health care provider, except in these cases:
 - network claims, and
 - during the preauthorization process.

What is next after a dispute for CEL?

- Insurance carrier's EOB or PLN01 or PLN11 is <u>not</u> final adjudication.
- Final adjudication is a final decision or order issued by DWC that is no longer subject to appeal by either party.
- Obtained through the DWC benefit dispute resolution process (BRC/CCH).

What is next after a denial for CEL?

<u>Do not</u> file for Medical Fee Dispute Resolution (DWC Form-060) this is not a dispute over reimbursement (fees).

Do:

- Develop a position statement, with any necessary causation or relatedness information.
- Attempt to resolve the issue with the injured employee and insurance carrier by requesting reconsideration (document this effort).

28 TAC Sec. 137.10, Return to Work Guidelines requires health care providers to use DWC's adopted RTW guidelines for the evaluation of expected or average RTW time frames

Doctor's Role in Return-to-Work

- Establish RTW or stay at work (SAW) expectations with the injured employee, beginning with the first visit, and discuss often.
- Communicate regularly with referral and ancillary health care providers about the injured employee's care and RTW expectations.
- Incorporate working into your treatment plan.
- Complete the Work Status Report DWC Form 073 and provide explanation if taken off work completely.
